If you are interested in applying, please call Lisa Anderson at (231) 883-6747.</li> </ul> <p><b>Substance Free Coalition of Northwest Michigan (SFCNM)</b></p> <ul style="list-style-type: none"> <li>The SFCNM Core Team met this morning and discussed ways to reach the Target Group #2 (students and parents).</li> <li>A liquor tax grant was submitted to NMRE requesting funds to continue the Know Dangers campaign. This will go to the SUD Board on 9/13/21; if they approve it will go to the NMRE Board for final approval.
