# A NOTE FROM THE COORDINATOR

Our next coalition meeting will take place on Thursday, June 9 from 4-5pm via Zoom. Dr. Whalen and Dr. Nefcy from Munson Healthcare will be joining us to provide information and answer any questions you all may have regarding the results of the recent Drug Enforcement Administration (DEA) investigation on Sixth Street Drugs, a Munson Healthcare subsidiary in Traverse City (<u>https://www.justice.gov/Usao-wdmi/pr/2022\_0526\_Sixth\_Street</u>). Dr. Dave McGreaham will be providing an update on the opioid settlement funds that Grand Traverse County will be receiving and Ken Kaufman will be providing an update on the Substance Free Coalition of Northwest Michigan's "Know Dangers" opioid use prevention campaign. Everyone is welcome and I hope that you are able to join us! The agenda will be sent out in an email early next week.

On May 4, the Substance Abuse and Mental Health Services Administration (SAMHSA) announced \$55 million in funding for the latest iteration of its Tribal Opioid Response Grant Program. ## **STAND**

Our Students Together against Negative Decisions (STAND) Clubs are coming to an end for the 2021/2022 school year. The students did a lot of great work this year and we are excited to start up again in the fall!

Three of our STAND Club seniors received a \$1,000 scholarship for their great work and leadership as a STAND Club member throughout their high school career. The recipients were:

- **William Gaston** Will is a senior at Traverse City West Senior High. He has been an active STAND Club member, member of Student Senate for three years, played varsity football, basketball, baseball, and track for 4 years. During his time as a STAND Club member, Will assisted in the STAND Drug Free basketball game, attended the STAND Youth Summit, volunteered with the coalition collecting toys at the Stuff a Blue Goose event, and planned a dodgeball fundraiser tournament with the proceeds going to a local substance use disorder (SUD) organization.
- **Erica McInnis** Erica is a senior at Kingsley High School (KHS). She has been an active STAND Club member for three years, on the National Honor Society for two years, received the Citizenship Award for KHS for two years, and was on the Honor Roll all eight semesters. During her time as a STAND Club member, Erica planned the March Madness activities and assembly and helped with positive culture building at KHS. After graduation, Erica will be attending Northwester Michigan College for two years and place to eventually transfer and receive her elementary teaching degree.
- Elizabeth Parker Elizabeth (Ella) is a senior at Kingsley High School. She has been an active STAND Club member for two years, on the National Honor Society for one year, received the Citizenship Award for KHS in 2019 and 2022, was on the Honor Roll from 2021-2022, received her academic letter, and was involved with the yearbook/web publishing for three years. During her time as a STAND Club member, Ella ran the student food pantry, Family Giveaway event, and Christmas Culture Building activities. After graduation, Ella will be attending Ferris State University to study elementary education.

## **COLOR FOR HOPE**

We have received a lot of community support so far and our Color for Hope fundraiser continues! These 18"x24" colorable posters come in four unique designs, two Traverse City and two Leelanau posters. The designs include businesses, landmarks, and scenery specific to these areas. The local artist, Susan Alexander, spent hours in the natural areas, businesses, and landmarks of Traverse City and Leelanau County areas to

capture the beautiful details. Susan Alexander lost her daughter to the disease of addiction. She is a passionate supporter of this cause and donated these posters as a way to further efforts to curb addiction and increase availability of resources related to education, prevention and treatment. All proceeds from the sale of these posters go to support SUD education, prevention, and treatment in our community.

The cost is \$15 for a set of two posters. The posters are currently available at both Oryana locations, ATS' The PORCH, The Red Dresser, Haberdashery, Premier Floral Design & Gift Emporium, Solitude Float and Wellness Spa, Peninsula Market, Anderson's Market, Leelanau Coffee Roasting Co., The Botanical Gardens, and the AREA Posters Facebook page. You can also email me directly and I can coordinate a pickup with you. Cash, credit cards, or checks, made payable to Catholic Human Services, are accepted.

We have collaborated with the Traverse City Downtown Development Authority for this project. They will be promoting and selling our posters for \$20; \$15 will be going towards our fundraiser and \$5 will go towards the Downtown Relief Fund. We have raised over \$11,500 so far and have purchased Naloxone Safety Kits that have been installed at the Woodmere (2<sup>nd</sup> floor), East Bay, Peninsula, & Kingsley libraries, Living Hope Church, Salvation Army, the 86<sup>th</sup> District Court, the 13<sup>th</sup> Circuit Court, the Goodwill Inn, the Friendship Community Center, Central United Methodist Church, the Northwestern Michigan College Library, the BATA Bus transfer stations, and the Traverse City Airport.
